Simple Options

1. Include a Gift in your Will or Trust

(see below for sample wording)

- You describe how you want your gift used
- You define the gift as a certain dollar amount or as a percentage of your estate.
- Advantage: Gifts in a will or trust may be changed at any time.

2. Make a Gift from your 401(k), IRA or other Retirement Plan

- You name Reality Ministries, Inc., as the primary or secondary beneficiary of the plan.
- You designate what percentage of the plan is for Reality Ministries.
- This estate gift may be created without an attorney.
- Advantages:
 - This estate gift may be created easily and without an attorney. It can also be changed at any time.
 - A person receiving this money outright would ultimately pay income taxes on it, but Reality Ministries would not.

3. Create a Charitable Gift Annuity

- Receive income payments for life after making a gift to Reality.
- Payments may begin immediately or at a future date.
- Income payments are based on the age(s) of the income recipient(s).
- Advantage: A portion of your gift is eligible for a charitable tax deduction.

Sample Wording for a Will or Trust

I give to Reality Ministries, Inc.* ("Reality Ministries"), a qualified 501(c)(3) charitable organization in Durham, North Carolina EITHER the sum of \$_____ OR ____ percent of my estate/trust, to be used in accordance with the terms of the most recent gift agreement and/or instructions, as amended, that I have signed with Reality Ministries, and if none exists, to be used as directed by the Executive Director of Reality Ministries.
